**WINNIPEG REGIONAL HEALTH AUTHORITY SELECTS  
QHR's EMR FOR REGIONAL CLINICS**  
*QHR strengthens Canadian EMR leadership position*

**Kelowna, BC, June 22, 2010 – (TSX-V: QHR)** QHR Technologies Inc. (“QHR” or the “Company”), a leading Canadian healthcare technology provider, announces that its EMR division, Optimed Software Corporation (Optimed) has entered into a contract with the Winnipeg Regional Health Authority (WRHA). Its modules manage key functions such as patient scheduling, billing (government, WCB, private and third party), electronic medical records (EMR), letters (including direct faxing), prescriptions, requisitions and other electronic forms, as well as electronic lab and diagnostic imaging results.

“Since becoming the first EMR vendor to meet Manitoba eHealth’s qualifications, QHR has grown its EMR business in Manitoba and has expanded its Winnipeg-based workforce. QHR has now contracted over 700 of Manitoba’s 2,400 physicians. The WRHA agreement, one of the largest of its kind in Canada, makes QHR the leading EMR provider in Manitoba,” said Al Hildebrandt, QHR’s Chief Executive Officer and President. “QHR’s EMS division is already the largest supplier of payroll systems for Manitoba’s healthcare employees, and provides financial systems to the majority of healthcare sites and regions in the province”.

WRHA is one of Canada’s largest regional health authorities, with acute care hospitals, long term care facilities and the 30 regional clinics. The WRHA prides itself on being one of Canada’s most forward thinking health authorities, assisting its providers and staff to deliver world-class healthcare solutions.
